### **Terms of Contract**

The fee for this service is \$1200 or a pick of litter which can be chosen once litter is whelped, if chosen that puppy an stay with Clubhouse Retrievers for future breeding or sold to another party, under a contract with the intent for breeding. Stud fee is due upon drop off of Bitch in Stud owner procession. If a pick of litter is chosen, the Bitch owner will be reimbursed for the stud fee that has already been paid. The puppies that go to homes outside of both parties will go to those under contract, that will state if at any time the family can no longer keep said puppy they will be returned to the Bitch owner or Clubhouse Retrievers. In this document it will also have records for all medical procedure(s) done for the puppy and any recommendation for what to do next. The stud owner cannot and will not be held liable if the Bitch requires a c-section during the labor process to retrieve any puppies resulting of this mating. This is to include that the Stud owner will not be held liable if the Bitch develops any infection as a result of this mating. The Bitch will be left in the hands of the Stud owner for the mating process, Stud owner will be sure to confine any other male(s) in the home that are not intended to breed with the Bitch. The Stud owner will document daily on the Bitches progress through her Heat cycle. Contact between both Bitch owner and Stud owner will be maintained through the duration of the mating process.

#### CONDITIONS STUD OWNER AGREES TO:

1. Provide bitch owner with a complete three generation pedigree of the dog.

2. Take normal, adequate care of the bitch while in our charge.

3. Have the stud dog in good physical condition, and current with annual vaccinations.

4. Sign litter registration promptly and return to bitch owner. (If Bitch is Registered)

5. Provide a return stud service up to a single time of the same dog to the same bitch if no pregnancy results from the mating at a discounted charge. To receive the return service, the bitch owner must notify the stud dog owner of failure to conceive, in writing, no more than 70 days following the mating. If the stud is no longer available for whatever reason for the return service, the stud owner reserves the right to offer a different stud to the bitch owner.

6. Provide the bitch owner with a written receipt for the stud service and a record of the breeding dates.

7. Offers to help with care of puppies whelped from this litter by assisting in removal of dewclaws and helping with deworming medications. (If needed- this does have a financial cost related to it)

8. Will confirm registration through AKC when New owners of have registered the puppies under their name. As far as stating that the puppy is in fact a product of the mating between Stud and Bitch listed above.

#### **BITCH OWNER AGREES TO:**

Pay the agreed stud service fee before or once the bitch is serviced (as stated above).
Provide veterinary certificate of current annual vaccinations, including Bordetella (kennel cough).

3. Send bitch in good health and in season.

4. Notify stud dog owner/agent, in writing, no later than 70 days after mating if no pregnancy results from the mating. Failure to do so will result in no return service being provided at a discounted rate.

5. Keep the bitch properly confined following the breeding to ensure no other dog could mate her accidentally before mating season is finished.

6. Agrees to not knowingly sell or transfer puppies whelped as a result of this mating to any firm connected with the business of resale or wholesale of dogs (Excludes the Stud Owner if they chose pick of litter).

7. Agrees to sell the puppies whelped from this litter on Limited Registration unless discussed with the Stud Owner prior to sell.

8. Have a negatived Brucellosis test within 14 days for mating.

#### **OTHER CONDITIONS:**

1. Three puppies born alive or dead constitutes a litter. However, if less than three puppies result from this mating, a return service will be provided at a discounted charge (\$600) to this same bitch at her next heat or within one year, provided all conditions of this contract have been met.

2. If the bitch fails to conceive on the second return service, this contract is terminated.
